Situational Awareness

- Both today's report of 353 new cases in Michigan and Wednesday's report of 323 new cases were the highest single-day totals the State has seen in the month of June so far.
- The nearly 37,000 new coronavirus cases reported nationwide yesterday, June 24, was the highest single-day total recorded for the United States during the entire pandemic.
- States with the highest reports of new cases include Florida, Oklahoma, South Carolina, Texas and California. Texas and California combined reported nearly 13,000 new cases yesterday. Epidemiologists are particularly concerned about Houston, Texas, which could become a new epicenter for the virus in the United States.
- A federal appeals court ruled that Gov. Gretchen Whitmer's order to keep indoor fitness facilities and gyms closed is a constitutional part of her office's emergency powers. A lower court judge had previously ruled that these facilities could reopen.
- A significant COVID-19 outbreak at Harper's Restaurant in East Lansing has infected at least 34 people. The count of those infected with the virus from visiting the establishment between June 12 and 20 continues to rise.
- The Wayne County Back to Work: Small Business Readiness Grant is available to Livonia small businesses. The funding for the grants was provided through the CARES Act. Up to 5,000 small business across the County could receive grants of up to. [Applications](#) are available until July 10.

Actions Taken

- The Clement Circle Splash Pad and Botsford Pool are now open. Social distancing, including the wearing of masks on the deck, is required. Residents are encouraged to make [reservations](#), with pool capacity lowered to comply with health officials' orders.
- The Kirksey Recreation Center is being prepared for re-opening when permitted. Members entering the facility will have their temperature digitally scanned, ensuring a quick, touch-free entry and greater safety for all members and visitors.
- The Livonia Fire Department has administered more than 500 COVID-19 antibody tests to City employees, including those returning from furlough. Individuals who test positive for antibodies are directed to St. Mary Mercy Hospital for a diagnostic test to confirm they are no longer positive for the virus.
- 33 Livonia small businesses have applied to receive grants through the City's CDBG Small Business Grant program. The funding for this program was provided to the City through the CARES Act. Their applications are being reviewed to ensure their eligibility for the program, and awards will be announced early next week.
