Due to the current CDC pause in administration of the Johnson & Johnson vaccine, there are some updates to upcoming Vaccinate Livonia appointments. Appointments previously scheduled for Wednesday, April 14 will be continuing as scheduled, with the Pfizer vaccine being administered by Livonia Fire & Rescue. Second-dose appointments are automatically scheduled for the same time three weeks after an individual's first-dose appointment. Vaccinate Livonia appointments scheduled for Friday, April 16 are canceled due to supply shortages created by the Johnson & Johnson vaccine pause. Those with appointments for this day will be contacted with information about further scheduling and other vaccination opportunities.
